



## CMCA Policy Agreement Form

1. I/We understand that CMCA is a non-accredited school (Independent Study Program).
2. I/We agree to attend 10 meetings per school year and to turn in paperwork when it is due the night of the meeting.
3. I/We understand that we may miss one meeting per year for emergencies or illness but there will be fees if more than one is missed, UNLESS I/we are paid in full or have an ACH and have NO paperwork due or ANYTHING to pick up. Then my/our absence will be excused.
4. I/We understand that I/we are considered absent if we do not put our Family Folder in the "Done Box".
5. I/We understand that the Wednesday after the meeting is only for those who missed the meeting because of an emergency or illness; Field Trip/Activity sign ups if you missed the opportunity at the meeting; and to help families and answer questions.
6. I/We realize educating our children through CMCA is our responsibility; we will not place blame on CMCA for failing in that purpose.
7. I/We agree to keep HSLDA membership current as part of our mandatory requirement for enrollment.
8. I/We understand that achievement testing is mandatory for 6th –11th grade students.
9. I/We understand that there are no refunds for Field Trips and Activities.
10. I/We understand that if we sign up for some events, but do not attend we will be required to pay a "no show fee" as noted in the Newsletter per event.
11. I/We understand it is our responsibility to know the information in the CMCA Handbook and follow the policies therein.
12. I/We understand that our high school students must abide by the Connect Guidelines found in the CMCA Handbook and will share these guidelines with them. I/We will be responsible for my student's actions at high school functions.
13. I/We understand that if our students take classes/sports at Calvary Murrieta Christian School we will abide by CMCS' policies and procedures located in the CMCS Handbook and will check the Advisements on-line for information and changes for each day. I/We realize this is our responsibility.
14. If CMCA/CMCS payments or paperwork is not current I/we understand that my student will not be allowed to participate in sports practices or games until payments are made and paperwork is current.

I/we have read the foregoing Policy Agreement and I/we fully understand what is expected of me/us. I am committed to uphold the standards outlined in this Agreement, and I/we am fully committed to my role as a parent/guardian and Christian role model at Calvary Murrieta Christian Academy. I/we also understand that agreeing with and adhering to this Agreement is a condition of my/our child's enrollment and that any public or publicly known violations or deviations from this Agreement are grounds for my/our child's expulsion.
